Aim of Christ in Action Food Bank

Supply to individuals and families in crisis three meals for 3 days plus basic hygiene requirements. In addition to assist families with children attending Newton Primary School, an area of recognised material deprivation, by supplying food to families and supporting the Supper Club initiated and funded by the school.

Trustees Report

The Trustee's wish to report that Christ in Action Food Bank has sustained the work of the previous record breaking year. We have delivered as requested by staff in hostels, housing agencies, community workers, council staff and NHS community workers 1982 bags of food. This is 4.8 times higher than pre Covid levels. Schools have received 1784 bags slightly lower than last year but still 2.8 more than pre Covid levels. The Women's Aid Refuge, which was open for a full year after renovations, received 51 deliveries and 209 individuals and 63 families benefited from a fresh meat meal delivered once a week. Our volunteer team of 18 has remained loyal and extremely hard working shopping for best buys tracking down hard to find items e.g. eggs, working in the store date checking and shelving, packing bags to answer all the above requests. The Trustees are grateful for their dedication.

After 10 years, Christ in Action Food Bank is well established within our community and gives help beyond food, our connections enabled people to knit children's warm clothes and blankets distributed through the winter, the singing group who donated money and young people were able to serve their community as they worked towards Boys Brigade President's Badges and Duke of Edinburgh Awards. The Trustees appreciate the ongoing support received from John Maurice Aitken Trust, Craigie Development Ltd., South Ayrshire Council, Tesco, Sainsbury's Hamilton's Butcher, and Grant's Fruiters, Store teams in B and M, Aldi. As a church based food bank we receive regularly from members and friends and because of all this trust and support the trustees are not burdened with fund raising but put all there energy into getting food to people who need it.

Christ in Action Food Bank plans to be available to fulfil its aims moving into what we perceive as another difficult year for many.

The trustees are grateful to Mr. Stewart Robertson for carrying out his duties as an independent examiner.


